- ✓ Women and Child Health
- ✓ Smoking and Tobacco use
- ✓ Stem Cell Gene Therapy

Submitting Abstract Eligibility

To be eligible for submission for an oral presentation, the following primary requirements must be met:

- ✓ A clinical research study concentrates on any conditions or treatments, whether registered or not, within ClinicalTrials.gov and is conducted in the United Arab Emirates.
- ✓ The clinical research study's status could be active, which means it is either recruiting participants or not recruiting yet but looking for participants.
- ✓ The principal investigator and research team have experience and qualifications relevant to the field of clinical research of the submitted presentations
- ✓ The research methodology in the submitted oral presentation has adequate research and scientific merits and is based on sound and scientific clinical research methods.

Evaluation Criteria-Submitted oral Presentation

- Abstract consistency with the type of clinical research study and the conditions /treatments, whether interventional or observational, of the clinical studies of the forum.
- ✓ Qualifications and expertise of the principal investigator and the research team
- Clinical Research study content that would include the purpose and methods of conducting, analyzing, discussing,etc
- ✓ Expected outcomes of the research project/generalizability

Registration is Free for submitting a paper and attending in-person through online registration on the Ministry's website.
