This service can be initiated by facility owners of government, a semigovernment or private pharmaceutical establishment which includes pharmacies, pharmaceutical stores and pharmaceutical stores for reexports, who have obtained the initial approval letter and fulfil the staff criteria respective to the facility type chosen in the license.
