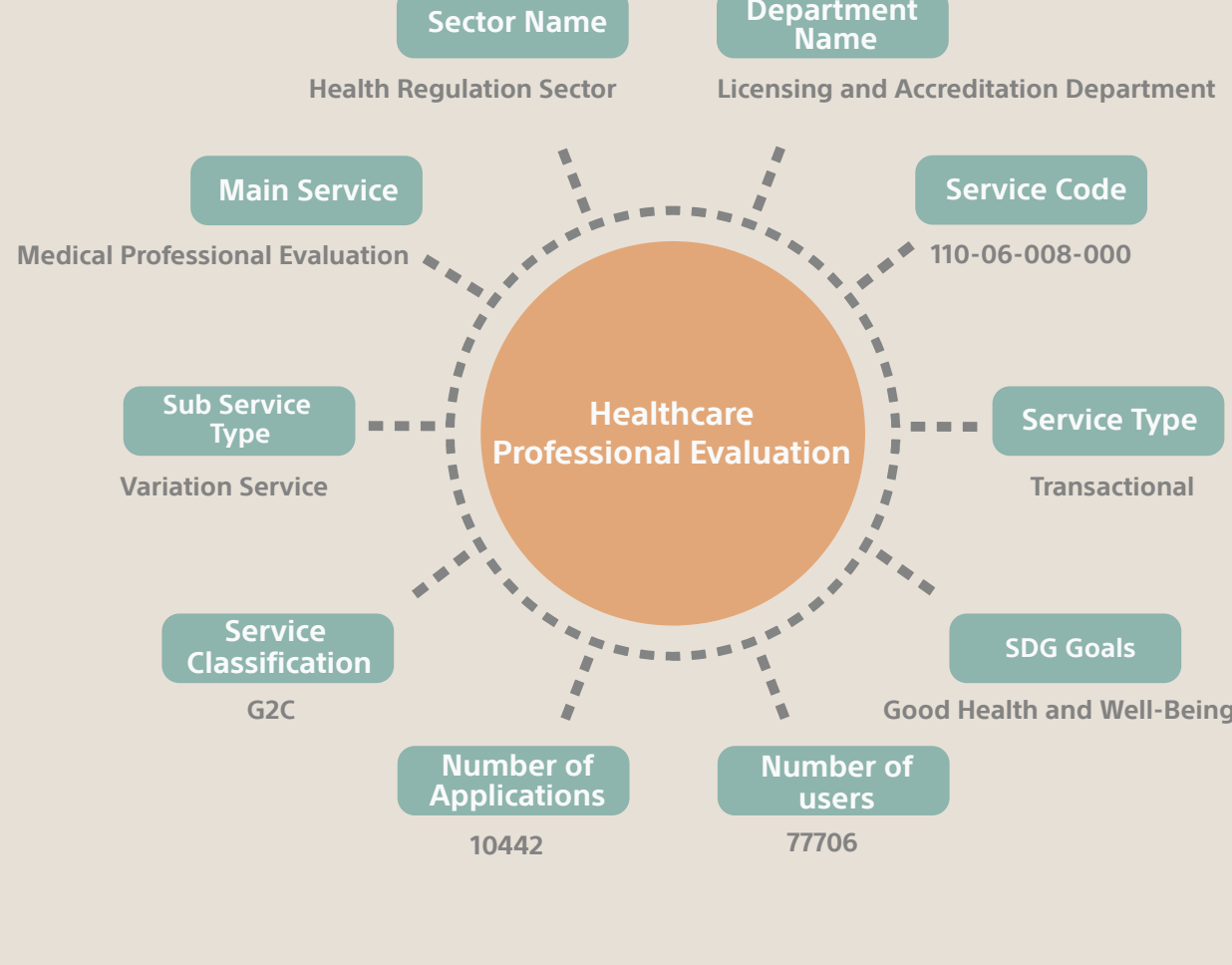


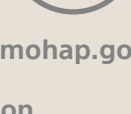
Health Professional Evaluation



Service Description

This service allows health professionals to obtain an evaluation certificate to issue the necessary licenses to practice the profession in the country, so that the extent to which scientific certificates and practical experiences are in conformity with the unified standards for licensing health professionals in the United Arab Emirates are evaluated, and then the level of knowledge is verified by conducting tests assessed.

Terms and requirements:



General Terms and Conditions

- There should be no practicing interruption of the profession for more than two years
- The certificate must be accredited in UAE
- Pass the prescribed tests, if required
- All documents submitted to "Data Flow" Company to be checked and the result of the report must be positive.
- Certificates are accepted in Arabic or English only, and if they are in other languages, the certificate must be legally translated and duly certified, and the two original certificates must be uploaded with the translated copy.
- In case of transfer from Abu Dhabi Department of Health or Dubai Health Authority, the license must be valid, and if it is not renewed or canceled, it must not exceed a period of 6 months, and in case of exceeding 6 months, the applicant is subject to the prescribed tests.
- Experience is calculated from the date of issuance of the license
- Pass the prescribed exams for each category.

Required Documents

- Academic qualification
- Duration of work experience corresponding to the field of specialization
- A professional license corresponding to the period of work experience
- Certificate of good professional conduct
- A valid passport
- Passport and family book for citizens
- The applicant's birth certificate and the mother's family book for children of female citizens

Procedures and Steps



- Login to the MOHAP website or smart application to apply for e-services, create an account, get username and password
- Fill out the required data and information, submit an evaluation request, and pay service fees
- You will be provided with a link to pay the certificate verification fees (Dataflow), and as soon as the fees are paid, the application procedures will be completed (either by transferring to the scheduled test or tests, or exemption from tests according to the terms and requirements of the exemption).
- Issuance of an assessment certificate in case of passing the prescribed tests (or exempting from the tests)
- In case of failure, the test will be repeated (the number of test attempts is 3 attempts for each category of tests)

FAQs



- How many trials are available to pass the prescribed tests?**
3 times only
- Can we accept old MOHAP evaluation?**
Evaluation certificate is valid for 5 years, as long as there is no gap of experience
- Are there any medical titles for evaluating UAE nationals only?**
There are medical titles limited to UAE nationals only which is as follows:
1- Assistant Psychologist
2- Assistant Service Specialist Social
Applicants should familiarize themselves with the conditions and requirements of each Title before submitting evaluation applications.
- Has training for new nursing graduates been cancelled?**
The training (six-month period) for new nursing graduates has been cancelled in case no more than two years have passed from the date of graduation, where the evaluation exam can be taken within two years from the date of graduation
- What are the conditions for applying for the exam to practice the profession for the dentist?**
