# Regarding Medical Products and Health Facilities that are excluded from Registration in the Drug Tracking and Monitoring Platform

## Minister of Health & Prevention

- After perusal of the following:
  - Federal Law No. 1 of 1972 AD on the Functions of the Ministries and the Powers of Ministers, as amended;
  - Federal Law No. 2 of 2019 on Use of the Information Technology and Communications in the Health Fields and its Executive Regulations;
  - Cabinet Resolution No. 59 of 2021 AD on Drug Tracking and Monitoring;
  - Ministerial Resolution No. 73 of 2021 AD on Pharmaceutical Products Tracking;

# Based on the public interest requirements

He does hereby decide the following:

## Article (1)

The following materials shall be excluded from registration in the Electronic Drug Tracking and Monitoring System "Tatmeen" under the aforesaid Cabinet Resolution No. 59 of 2020 AD and Ministerial Resolution No. 73 of 2021 AD:

- 1- Intravenous nutrition solutions;
- 2- Radioactive drugs;
- 3- Diagnostic imaging medications of all kinds;
- 4- Blood, blood products and blood derivatives;
- 5- Medical gases;
- 6- Medical products of limited and rare demand;
- 7- Compound medicinal products prepared within the Country in licensed compound pharmacies;
- 8- Any other medical product of which justifications are approved by the Drug Department according to the Ministerial Resolution No. 73 of 2021 AD on Pharmaceutical Products Tracking.

## Article (2)

The following entities shall be excluded from registration in the Electronic Drug Tracking and Monitoring System "Tatmeen" established under the aforesaid Cabinet Resolution No. 59 of 2020 AD and Ministerial Resolution No. 73 of 2021 AD:

- 1- Diagnostic centers (laboratories and imaging centers);
- 2- Rehabilitation centers, except for the addiction and mental illness rehabilitation centers;
- 3- School clinics;
- 4- Health centers and clinics that do not trade in the medicines (dispensing or dealing);
- 5- Sub-units of the medical ambulance.

# Article (3)

The Health Regulation Sector in the Ministry may extend the regularization period specified in Article (6) of the aforesaid Ministerial Resolution No. 73 of 2021 for the period it deems proper to enable the regularization. In addition, the Health Regulation Sector may make an exception from implementing the aforesaid Resolution whenever the exception is justified.

# Article (4)

This Resolution shall be published in the Official Gazette of the Country and shall be effective as of the day following the date of publication thereof.
